Boston Foundation Makes Online Funding Database Available to 130 Urban Schools

ROSSLYN, VA- School Funding Services, a unit of the Education Entrepreneurs Fund, announced that the Boston Educational Development Foundation has signed a two-year contract to provide funding solutions to all public schools in Boston, Massachusetts.

Through a contract with School Funding Services (SFS), schools and districts within Boston have a tool that will help them easily locate public as well as corporate and foundation funding.

In addition, SFS has packaged a suite of services that include analytical reports on funding legislation and trends, as well as the latest education funding news. The district will receive password-protected access to the SFS database and Web site and will receive training on usage of the online service.

"Empowering schools and districts to raise money beyond their budgets is the driving force behind School Funding Services," said Matt Pickering, School Funding Services' Business Development Manager. "We are helping to build fund-raising capacity at the school level, thereby helping them to select the *right* programs for their school without basing that selection solely on costs."
